Rules & Paybacks

Futurity Rules:

1. Classes are open to all horses with APHA registration papers (regular or breeding stock). Must have copy of papers.
2. The exhibitor is responsible for showing in proper equipment as defined by APHA rules.
3. A tie-breaker judge will be chosen prior to the start of the futurities. In the event of a tie, money will be combined and split evenly, the tie breaker judge's placing will be used to break the tie for awards only.
4. Payback percentages will be determined by the number of horses entering the gate.
6. Checks will be mailed within 30 days.
